I would hope you know that we have absolutely nothing to hide, this should be clear from the fact that we had already asked Troy Charter and Scott Krieger if they would like to attend the 30minute internal meeting between Alstom and OLRTC. Yesterday we sent Michael Morgan an email suggesting that he, Scott, myself, Mark Turner and Peter Lauch meet to review the vehicle deficiencies. This afternoon we dialled Scott into the 4pm meeting in order that he could listen to the daily progress meeting we hold.

At 8am tomorrow morning I am already in a meeting with Alstom senior management, including Jerome Wallut and my Exco. Therefore I will not be able to meet with Eric and Tom until after that meeting has finished. We then have our weekly progress meeting with Alstom from 9am to 9:30am. This is immediately followed by the Alstom MRS meeting which I know Eric already attends. As such, meeting after that from midday to 4pm made the most sense to us. It will ensure that your team have full access to all of my team and Alstom to undertake a visual inspection of vehicles and to discuss any issues and concerns that the City may have.

I am sorry that you think we are being obstructive or hiding anything, quite the opposite, we are trying to be as open as possible. As I am sure you can appreciate a 30min meeting is not long enough to go into any level of detail on any specific items, hence why we felt it would be more beneficial to provide a longer dedicated period to the team.

So, as you wish, your team are welcome to attend our regular 30min progress meeting, but we still feel that the real added value and benefit to the project is in a more in depth discussion between midday and 4pm. Once again, we have nothing to hide and we will gladly afford Tom, Eric, and the rest of the team the time they need to understand the current position on the fleet.
